

2018 Sponsorship Pool Application

Sponsored families who are applying for a pool pass agree to abide by all rules and regulations of the swimming pool.

Pool passes will only be given to immediate family members: father, and/or mother, guardian, and children. Please see the rules/ regulations on page 15 of the newsletter.

If sponsored families inappropriately pay for pool passes (i.e. without a Forest Hills Resident sponsor), or are misused, lent out or improperly obtained, those passes will be immediately revoked without a refund.

Only 25 applications will be selected, and sponsored families who received a 2017 Family Pass will get first consideration for the 2018 pool pass, but only if the applications from both the resident and sponsored family are filled out correctly and all fees are paid.

Sponsored families are only eligible to purchase a family pass.

2018 Forest Hills Pool Pass*

\$550 – Family Pass

No other passes (individual, senior citizen or Plus Packages) will be available to sponsored families.

- The pool will open on Saturday, May 26 through August 10 from noon to 8 p.m. every day (weather permitting). Due to staffing limitations from August 11 to Labor Day (September 3), the pool will be open Monday through Friday from 4 to 8 p.m.
The pool will be open regular hours on Saturdays and Sundays from August 11 to September 3 (noon to 8 p.m.)
- The refreshment stand is open noon to 7 p.m. with the grill closing at 6:30 p.m.

*All applications and required payments (resident sponsors and sponsored families) must be received at the borough office no later than the close of business day May 1.

2018 Pool Rules and Regulations for Residents

An application for a pool and/or tennis pass will be accepted only if completed in full and submitted on the annual pass application form.

- All applicants must be full-time borough residents
- Minors under the age of 11, residing in the borough, whose parents or legal guardian(s) qualify as a borough resident, pays the applicable fee for a family pool pass and,
- Minors, age 11 and over, residing in the borough.

Residency is defined as living in the borough full-time throughout the calendar year or living in the borough during the months of June, July and August. In either case, the pool pass may be declined or revoked if satisfactory evidence of residency is not provided. Acceptable proof of residency includes: Current Pennsylvania driver's license or some other form of photo identification, and/or a current utility bill or tax receipt showing the residency address.

All persons seeking permission to enter the pool must present their pool tag attached to their garment or provide evidence needed to satisfy residency requirements. All other persons will be denied access to the pool, unless as a paying guest of a Forest Hills Resident.

Residents bringing guests to swim must accompany those guests at all times. Residents cannot drop off their guests and leave the facility. Residents are responsible for their guests and their guest's activities while at the pool.

Check babysitter registry with cashier (babysitters do not get pool tags).

2018 Sponsored Families by a Forest Hills Resident Additional Rules and Regulations

- Applications for the sponsorship program will be closed on May 1 if the maximum number of applications are received (25). If the borough does not receive 25 applications by May 1 (for non-residents and residents), then the sponsored families along with their resident sponsors may purchase applications once the pool opens on (and after) May 26, and only until the maximum number is reached.
- Sponsored families will pick up their pool tags on or after the first day pool is open.
- Resident sponsors must have purchased a 2017 pool pass to be eligible to sponsor a family.
- Forest Hills Residents sponsoring a family must have purchased a pool pass at the same time the sponsored family's application is being reviewed for approval.
- If a sponsored family is ejected from the pool for any reason their pool tags will be revoked (without a refund), and the resident sponsor's pool tags will also be revoked (without a refund).
- Sponsored families will be permitted to bring up to two guests to the pool; those guests will pay the non-resident daily admission price.
- Sponsored families consist of mother and/or father, guardian, and children living with parents during the summer. Sponsored families are permitted to have babysitters bring their children to the pool, but must be registered at the cashier's booth, and must check in each time visiting the pool (babysitters do not get pool tags).
- Resident sponsors will be permitted to sponsor up to three non-resident families.
- Sponsored families will have to apply each year for a pool pass with a resident's sponsorship, but will be considered first when applications are under review.
- Approved sponsored families will also be eligible to join the Forest Hills Swim Team, the Forest Hills Synchronized Swim Team and the Forest Hills Tennis Team. Applications for those programs are on pages 9 to 12 of this newsletter.
